

LEGAL DESCRIPTION

Commencing at Point No. 16 of said plat of Soda Hill Estates, from whence Corner No. 16 of said Montague Placer bears N45°51′34″E, 770.27 feet, said point being the True Point of Beginning; thence N49°32′52″W 90.83 feet along the southwesterly line of said plat; thence departing said southwesterly line N48°12′26″E, 136.26 feet; thence S41°47′34″E, 90.00 feet to a point on the southeasterly line of said plat, said southeasterly line being the line between Point No. 15 and Point No. 16 of said plat and the basis of bearing for this description; thence on and along said line S48°12′26″W, 124.00 feet to the True Point of Beginning, containing 11,711.5 square feet, 0.27 acres more or less.





